TERMS AND CONDITIONS

- 1) The promoter is Diabetes Victoria (ABN 71 005 239 510) of Suite G01, 15-31 Pelham Street Carlton VIC 3053.
- 2) Accessing the benefits associated with the free 6-month membership offer (including emails, newsletters and other benefits) will be deemed as your acceptance of these terms and conditions. You must comply with these terms and conditions for your free membership to be valid.
- 3) This offer will be available to;
 - New National Diabetes Services Scheme (NDSS) Registrants who are newly registered and have opted in to receiving communications from Diabetes Victoria. AND/OR
 - Those who have never been a member of Diabetes Victoria or haven't been a member for 10 year or more.
- 4) If you meet the eligibility criteria, your free 6-month membership offer will be activated when you opt in to receiving communications from Diabetes Victoria. Or after Diabetes Victoria approve your application for the free 6-month membership.
- 5) The free 6-month membership offer entails 6 months of membership with Diabetes Victoria. During your 6-month free membership you will receive digital communications and digital member benefits only.
